**Public is Invited to Participate in Federal  
Certification Review of the SMTC**

**SYRACUSE, N.Y.** – Federal regulations stipulate that Metropolitan Planning Organizations such as the Syracuse Metropolitan Transportation Council (SMTC) must undergo a federal onsite certification review every three years. Conducted by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA), the certification review is conducted to ensure that transportation planning requirements are being satisfactorily implemented by the SMTC. As part of the review, the following public meeting will be held:
