SMTC Implements 2002-2003 Winter Special Events Traffic Management Plan

SYRACUSE, N.Y. – The **Syracuse Metropolitan Transportation Council (SMTC)** has announced the implementation of the 2002-2003 Winter Special Events Traffic Management Plan. The annual Plan is in effect for all Carrier Dome special events, including Syracuse University's home basketball games.

The purpose of the Plan is to promote traffic flow and enhance air quality on streets serving the Carrier Dome and in surrounding residential neighborhoods. One of the most important goals of the Plan is to limit vehicular traffic on Adams Street and Almond Street in order to ensure smooth traffic flow. The Plan urges motorists to use alternative routes and means of travel to get to events held at the Carrier Dome ([see attached "Special Events Routes" map – JPEG file](#)).

The SMTC suggests the following:

- Use routes to various parking lots in the Syracuse University area that bypass the Adams Street/Almond Street intersection.

- Park in the Ontrack lot at Armory Square, and utilize the special “basketball trains” to the Carrier Dome. For schedules and fares, call (315) 424-1212.
- Use regularly scheduled Centro bus service and special buses operating from park-n-ride lots, when traveling to the Carrier Dome. For routes and fares, call (315) 442-3400.
- Carpool
- Travel by foot
