**SMTC REVIEWS TRANSPORTATION DEVELOPMENT -- *PAST, PRESENT & FUTURE* -- IN LONG-RANGE TRANSPORTATION PLAN
2004 UPDATE**

SYRACUSE, N.Y. -- The Syracuse Metropolitan Transportation Council (SMTC) has officially adopted the Syracuse Metropolitan Area's *Long-Range Transportation Plan (LRTP) – 2004 Update*. The SMTC Policy Committee formally endorsed the document at their June 30, 2004 meeting.

The LRTP is a blueprint to guide the Syracuse Metropolitan Area's transportation development over a 25-year period. Updated every three years to reflect changing conditions and new planning principles, the **LRTP 2004 Update** looks at major urban transportation planning issues such as environmental/air quality; complete access to transportation; alternative transportation modes (i.e., bicycle and pedestrian); the impact of land development on the transportation system; highway traffic congestion; and maintenance of the existing infrastructure. Also included is the **Conformity Analysis**, which successfully determines that the SMTC is in conformity with the applicable New York State Implementation Plan (SIP) for air quality in its adoption of a Transportation Improvement Program (TIP), Long-Range Transportation Plan, and any pertinent amendments or updates.
