Annual Obligation Project Listing

Federal Fiscal Year 2018

(October 1, 2017 through September 30, 2018)

Federal regulations require an annual listing of transportation projects, including investments in pedestrian walkways and bicycle facilities, for which federal funds have been obligated in the preceding federal fiscal year (FFY) be made available for public review by the Metropolitan Planning Organization. The listing must also be consistent with the funding categories identified in the Transportation Improvement Program (TIP).

What are project obligations?

An obligation is the U.S. Department of Transportation's legal commitment to pay the federal share of a project's cost. Projects for which funds have been obligated are not necessarily initiated or completed in a given program year, and the amount of obligation in a single year will not necessarily equal the total cost of the project.

Project Phases

The TIP identifies project costs and schedules by phase. These phases are:

- **Scoping:** This phase involves meetings with project developers and designers, local government representatives, and other involved parties. Decisions are made about the specific elements that will be included in the project and the range of design alternatives that will be investigated.
- **Preliminary Design:** This phase includes basis engineering work on each alternative, traffic studies, environmental analyses, and other work specific to the project. Public outreach in accordance with state and federal requirements is used to gain community input on the project. A preferred alternative is selected to advance the project.
- **Detailed Design:** This phase includes detailed engineering work on the preferred alternative. This phase results in the plans and specifications that the construction contractor will work from.
- **Right-of-Way Incidentals:** Preparation work done prior to the acquisition of the right-of-way.
- **Right-of-Way Acquisition:** This phase includes the acquisition of right-of-way (property) necessary to complete the project. Acquisition can be achieved through the purchase of property or an easement.
- **Construction:** This encompasses all work necessary to build the project.
- **Inspection:** This phase includes ongoing inspection to ensure construction is performed properly and conforms to specifications. This work is often contracted out.
- **Other:** This phase is associated with transit projects, and corresponds to the construction phase of the highway improvements, in that it represents that phase of the project where in the proposed improvement is actually implemented. For transit projects, it usually involves the purchase and acquisition of vehicles and associated preventive maintenance, though in some cases, such as for station, parking and maintenance/storage facilities, the construction of fixed or permanent facilities is undertaken.

Project Listing

The following table lists all projects from the SMTTC 2017-2021 TIP that had funds obligated during the 2018 FFY. The list of obligated projects is organized and presented consistent with the 2017-2021 TIP. For each project, the list includes:

- The Project Identification Number (PIN) used to track the project;
- Project name;
- Project sponsor;
- Project type (i.e., bicycle, pedestrian, etc.);
- Project phases obligated in FFY 2018; and
- Amount of federal funds obligated by phase in FFY 2018.
