



Announcement of public comment period

Amendment to 2023-2027 Transportation Improvement Program

The Syracuse Metropolitan Transportation Council (SMTC) is seeking public comment on the proposed amendments relative to the 2023-2027 Transportation Improvement Program. This action includes the following:

Change in cost and/or schedule

- PIN 350186 (BRIDGE REHAB, I-81, OVER ROUTE 11, NEDROW, ONONDAGA CO).
 - Sponsor New York State Department of Transportation (NYSDOT). NYSDOT is proposing to delay the Detailed Design phase from Federal Fiscal Year (FFY) 23/24 to FFY 24/25 and program as \$900,000 NHPP federal funds and, delay the Construction and Inspection phases from FFY 24/25 to FFY 25/26 and program as \$18,500,000 State Dedicated Funds (SDF) and \$1,850,000 SDF, respectively. Compensating offset provided by delay of Construction and Inspection phases and SDF.
- PIN 307629 (SUPERSTRUCTURE REPLACEMENT, RT 20 OVER LIMESTONE CRK, POMPEY, ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to delay the Detailed Design phase from FFY 23/24 to FFY 24/25 and program as \$480,000 NHPP federal. Compensating offset provided by PIN 350186.
- PIN 350184 (BRIDGE REHAB, I-81, RAMPS TO HIAWATHA & CR 137, SYRACUSE, ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to delay the Detailed Design phase from FFY 23/24 to FFY 24/25 and program as \$720,000 NHPP federal. Compensating offset provided by PIN 350186.
- PIN 350188 (BRIDGE REHAB, HIAWATHA BLVD, OVER I-81, SYRACUSE, ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Detailed Design phase in FFY 24/25 by \$331,000 NHPP federal funds. Compensating offset provided by PIN 350186.
- PIN 350189 (MBC, I-81, SYRACUSE CITY LINE TO MATTYDALE, TN OF SALINA, ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Construction and Inspection phases in FFY 24/25 by \$3,600,000 NHPP and \$360,000 NHPP federal funds, respectively. Compensating offset provided by PIN 350186.
- PIN 307625 (MBC, RT 20, CAYUGA CO LINE TO RT 175, TN & VIL OF SKANEATELES, ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Detailed Design phase in FFY 24/25 by \$160,000 NHPP federal funds. Compensating offset provided by PIN 350186.

 - Sponsor NYSDOT. NYSDOT is proposing to increase the Detailed Design phase in FFY 24/25 by \$150,000 NHPP federal funds. Compensating offset provided by PIN 350186.
- PIN 350199 (BRIDGE REHAB, I-81, OVER ONEIDA RIVER/BARGE CANAL, ONONDAGA & OSWEGO CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Detailed Design phase in FFY 24/25 by \$900,000 NHPP federal funds. Compensating offset provided by PIN 350186.
- PIN 380553 (REHAB/REPLACE, LARGE CULVERTS, VARIOUS LOCATIONS, ONONDAGA & OSWEGO CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Construction and Inspection phases in FFY 24/25 by \$400,000 NHPP and \$37,000 NHPP federal funds, respectively. Compensating offset provided by PIN 350186.
- PIN 380668 (SAFETY APPURTENANCE PROGRAM (SAFETAP), ONONDAGA CO).
 - Sponsor NYSDOT. NYSDOT is proposing to increase the Construction and Inspection phases in FFY 24/25 by \$890,000 NHPP and \$89,000 NHPP federal funds, respectively. Compensating offset provided by PIN 350186.
