# Synopsis

The SMTC staff prepares the Federal Fiscal Year annual report to capture fiscal and capital program management relevant “end-of-year” items. This multi-page graphical financial summary covers a variety of topics and is supportive of the transparent, performance-based planning and programming process used in the maintenance of the Transportation Improvement Program (TIP). Although projects on the TIP are funded with federal, state and local funds that when combined provide a “Total” cost, the information in the following pages is mostly based on federal transportation dollars from the Federal Highway Administration (FHWA) or the Federal Transit Administration (FTA) programs, with one exception. “Major Projects” are identified according to a project’s “Total” cost of the construction and inspection phase. This is the sixth summary.

At the close of Federal Fiscal Year 2023/2024 (October 1, 2023 – September 30, 2024), the TIP programmed \$502.221M federal FHWA funds to five sponsors. Of the five sponsors, 96% of the funds were programmed to the New York State Department of Transportation. Both the large federal programmed value and the State’s percentage relate to the programming of four Interstate 81 Viaduct Project capital projects: PIN 350193 (Bridge, New & Replace, I-690 over Crouse & Lodi), PIN 350194 (Business Loop 81, Southern Section, Phase 1), 350196 (Business Loop 81, Northern Section, Phase 2), and PIN 350197 (Business Loop 81, Southern Section, Phase 2). The next two annual reports will show similar percentages for NYSDOT as federal funds are programmed in additional years for Interstate 81 Viaduct Project contracts.

Overall, 100% of FHWA programmed funds were obligated in the Federal Fiscal Year. Regarding FTA federal funds, \$27.291M was programmed at the end of the year with 100% of FTA funds obligated.

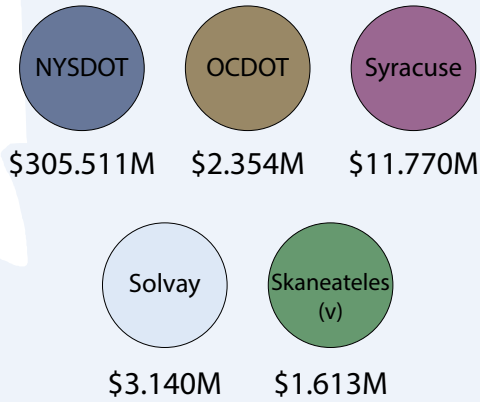

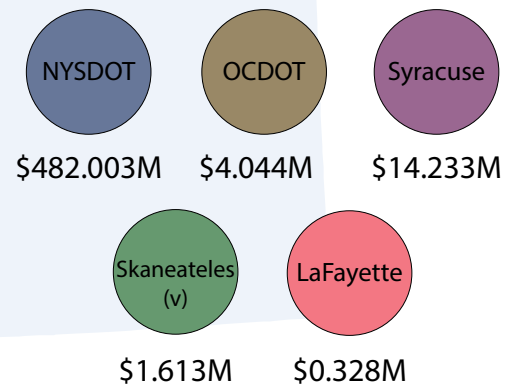


# Programmed Dollars by Sponsor

October 1st

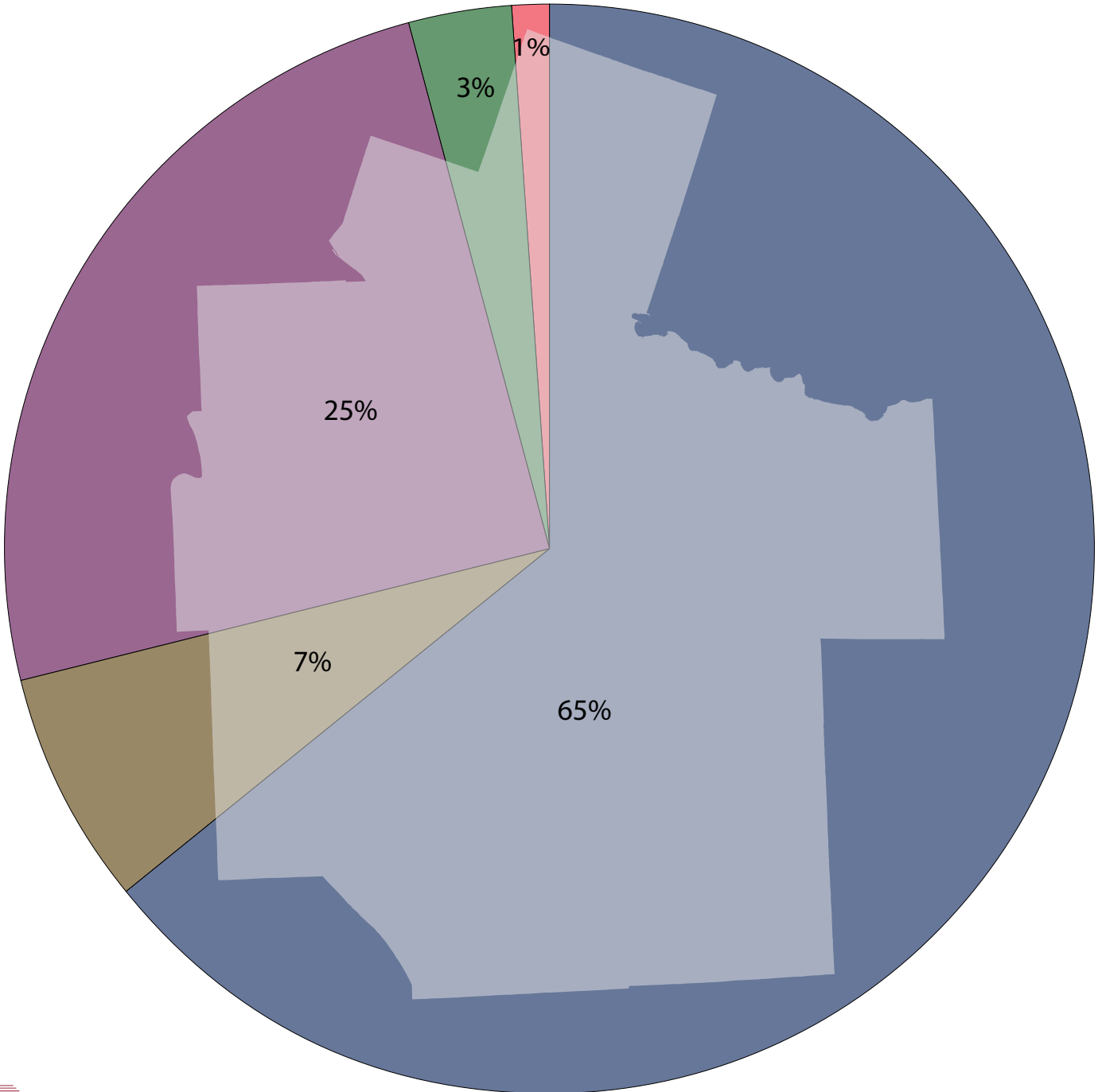


September 30th

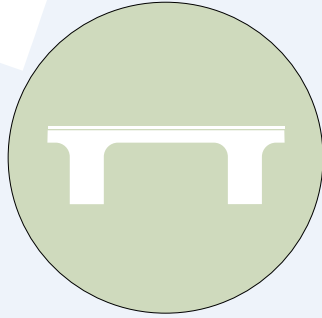

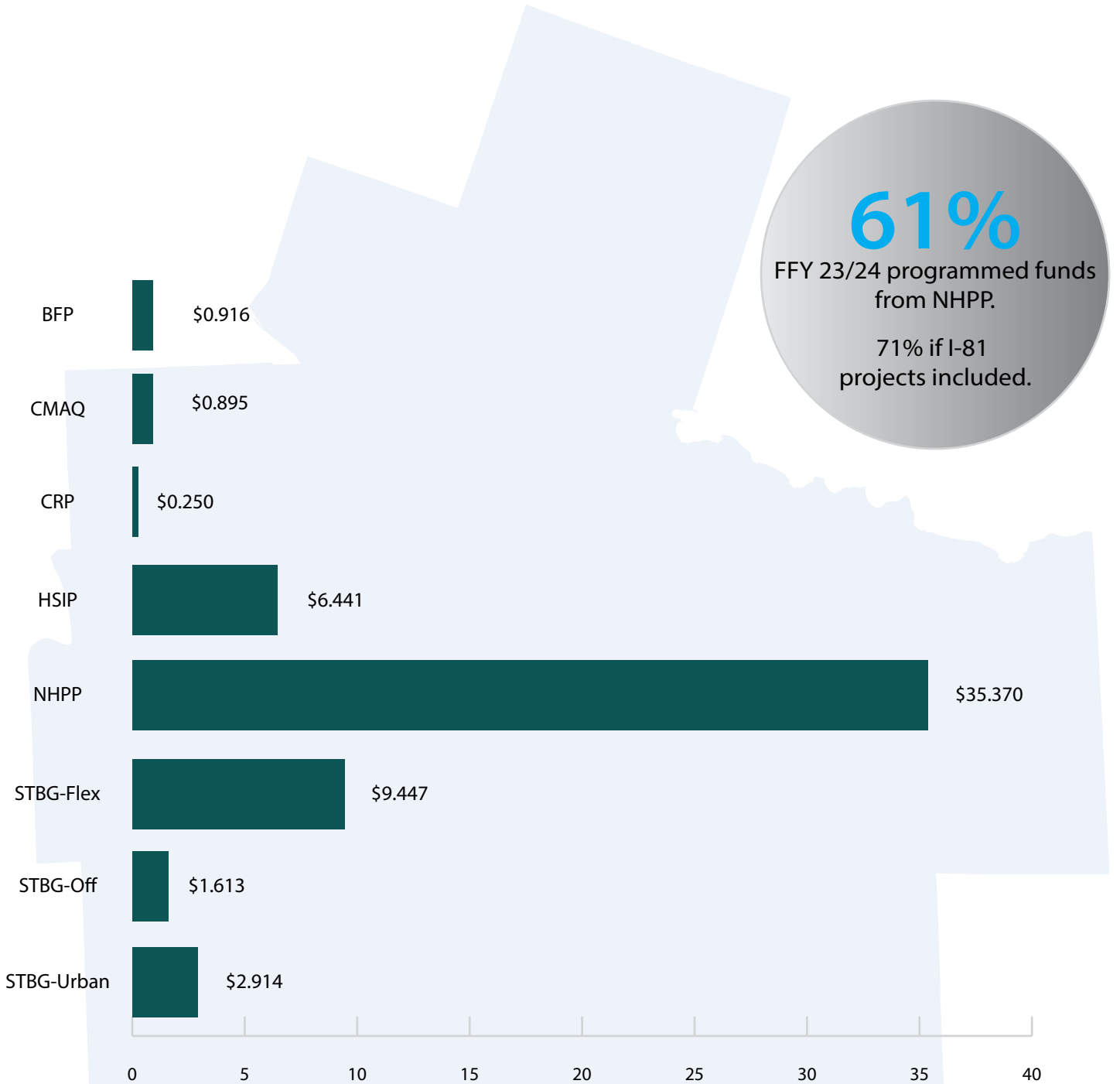

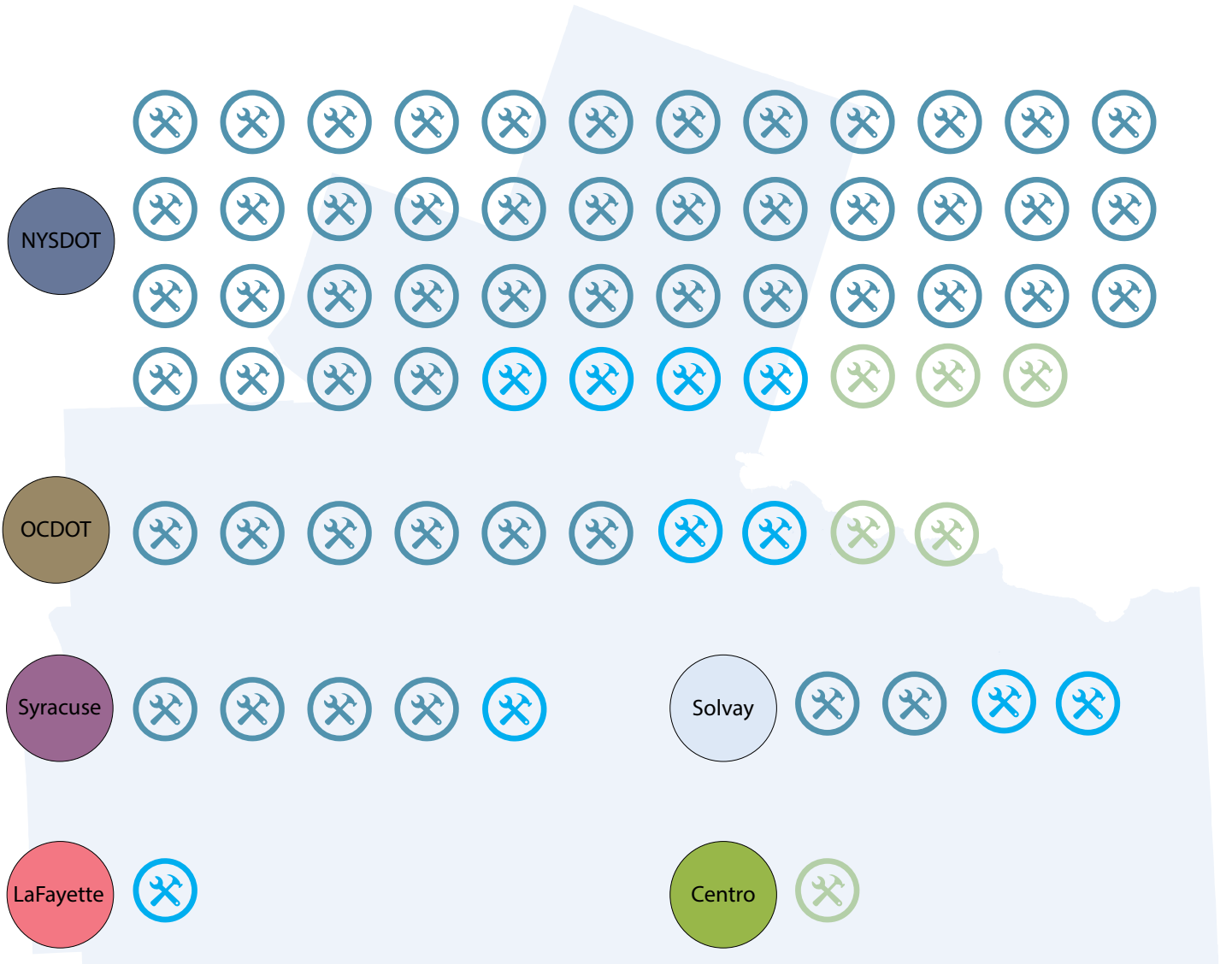

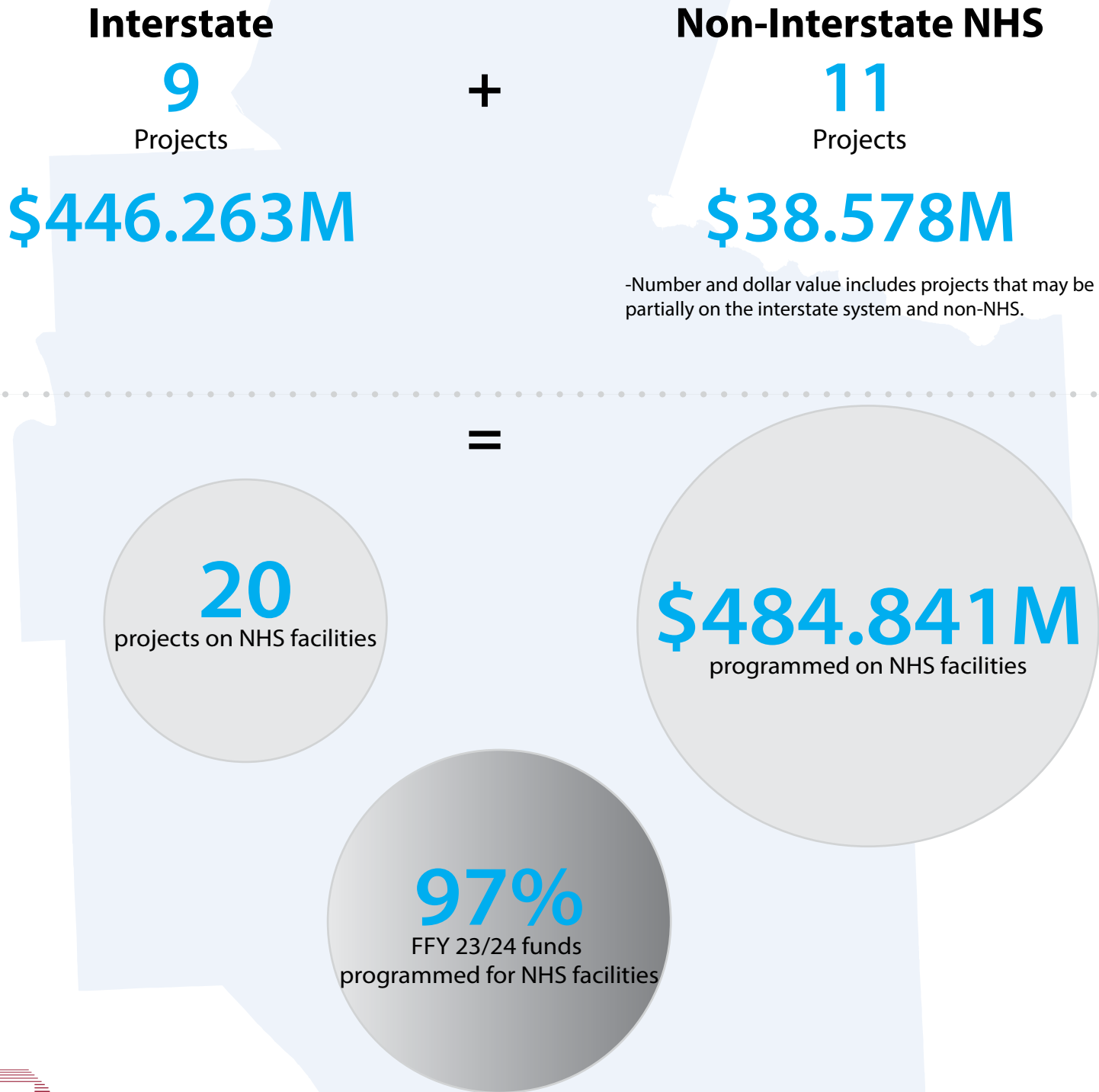

# National Highway System Projects

- Federal surface transportation authorizations emphasize a performance-based planning & programming process. Several national performance measures are established that relate to conditions, and reliability of, the National Highway System (NHS). The graphic is reflective of funds programmed in FFY 23/24 to NHS facilities for any project phase, and not limited strictly to construction.



-Number and dollar value includes projects that may be partially on the interstate system and non-NHS.

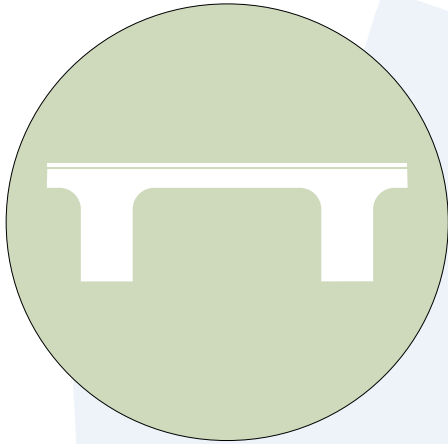

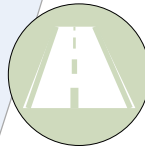
# Environmental Justice Areas

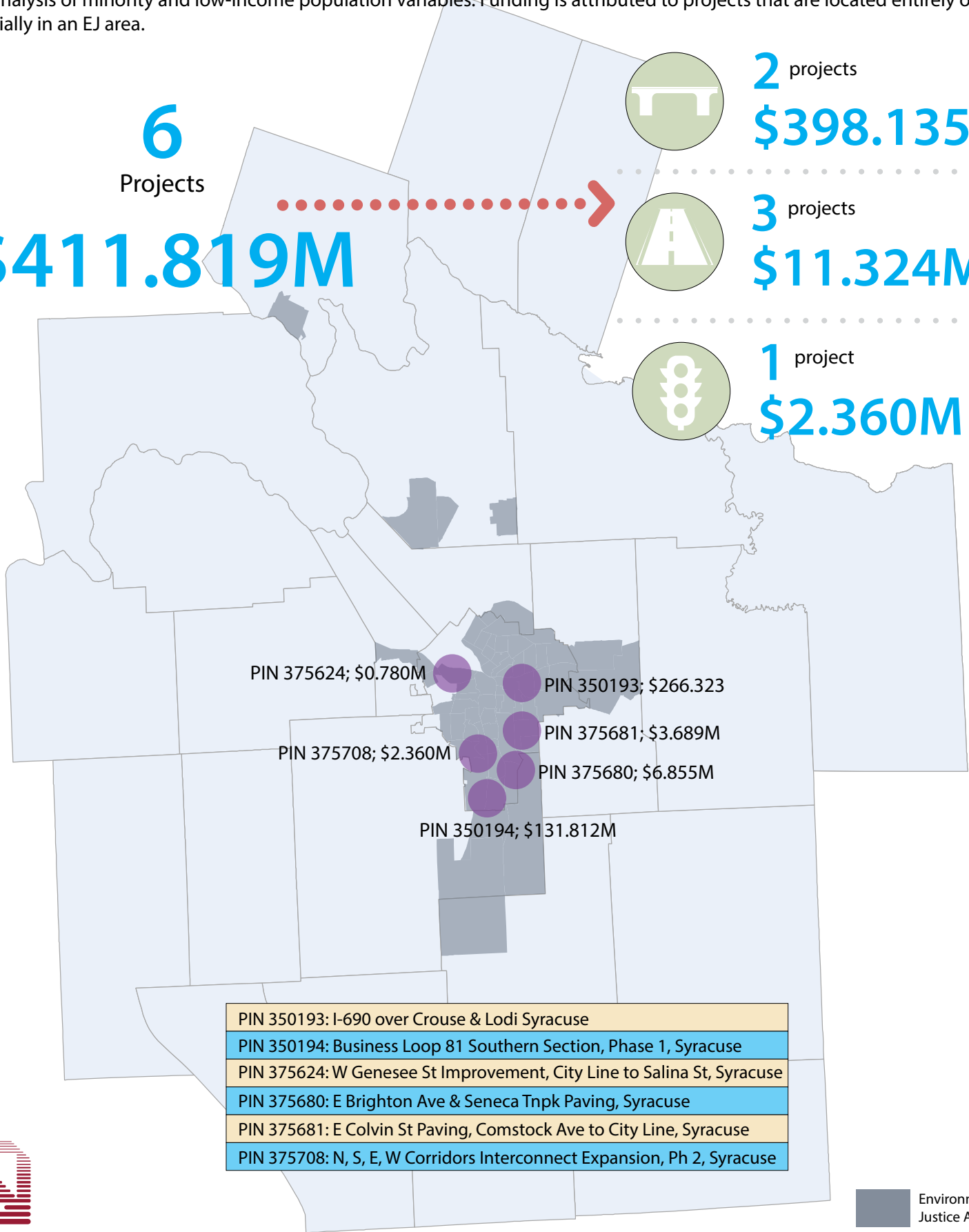

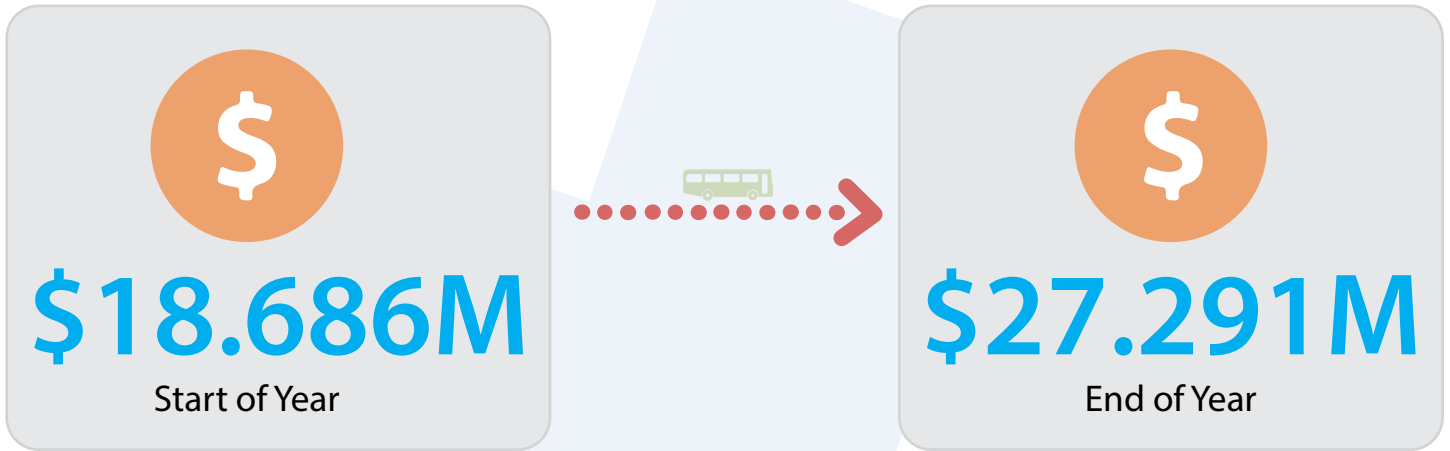
