

# Announcement of public comment period Amendment to 2023-2027 Transportation Improvement Program

The Syracuse Metropolitan Transportation Council (SMTC) is seeking public comment on the proposed amendments relative to the 2023-2027 Transportation Improvement Program. The action includes the following:

Addition or deletion of project

- PIN 395095 (SOLVAY-GEDDES CONNECTIVE CORRIDOR PROJECT, TN OF GEDDES & VIL OF SOLVAY, ONONDAGA CO).
  - Sponsor Town of Geddes. Total cost \$6,250,000. The Town was awarded \$5,000,000 Congressional directed spending to design and construct a complete street, connective corridor along various roads linking the Village of Solvay and City of Syracuse to support ongoing revitalization efforts within the community. Engineering and Design phases in Federal Fiscal Year (FFY) 24/25, with Construction programmed in FFY 26/27. \$1,250,000 Match provided by the Town.
- PIN 350200 (MEDIAN BARRIER UPGRADE, 181 NB OVER RT 80 TO 2 MI N EXIT 24, TN OF TULLY, ONONDAGA CO).
  - Sponsor New York State Department of Transportation (NYSDOT). NYSDOT is proposing to remove this project from the current TIP as activities will be addressed under PIN 380668: Safety Appurtenance Program in FFY 24/25.

- *WHEREAS,* This project is sponsored by the Town of Geddes (Town); and
- *WHEREAS*, PIN 395095 is not currently listed in the 2023-2027 Transportation Improvement Program (TIP); and
- *WHEREAS*, The Town has received federal funds for a connective corridor project in the Village of Solvay, within the Town of Geddes; to address sidewalk, ADA and safety improvements on Charles Avenue, Fay Road and Grand Avenue; and
- *WHEREAS*, The Town is proposing to add the project to the current 2023-2027 TIP, specifically the Scoping, Preliminary Design and Detailed Design phases in Federal Fiscal Year (FFY) 24/25, with \$352,000, \$264,000 and \$264,000 of Miscellaneous Federal Aid funds respectively; and the Construction and Inspection phases in FFY 26/27 with \$3,744,000 and \$376,000 of Miscellaneous Federal Aid funds respectively, as reflected in the table on the following page; and
- *WHEREAS,* The offset is provided by Congressional directed spending; and
- *WHEREAS*, This reflects a new project added over \$500,000, thereby requiring Policy Committee approval under the current TIP Project Management & Administrative Modification Matrix; and
- *WHEREAS*, The SMTC 2023-2027 TIP and the NYSDOT STIP would remain fiscally constrained with the approval of this change.

**NOW THEREFORE BE IT RESOLVED**, that the SMTC Policy Committee endorses the above action and modification of the 2023-2027 TIP and NYSDOT STIP.
