

Major Projects from the 2023-2027 TIP

As required by 23 CFR Part 450.326(n)(2), the following table highlights the major projects that were implemented or delayed from the 2023-2027 TIP. The listing below is specific to the first, second, and third year of the 2023-2027 TIP (i.e., Federal Fiscal Year [FFY] 2022-2023 through 2024-2025, which covers October 1, 2022 through September 30, 2025).

The SMTC has defined a major project as any TIP project with an overall total construction and inspection cost (i.e., federal funds + match) of \$3 million or more. As such, the number of construction projects contained in the information below may be less than the actual number of construction projects programmed in a given year.
